III. FIANGTERNAK

Zaranin Liamkuan Zat (Amounts Generally Billed -AGB): Caakkhai lole siivai tul tengteng ruang ah insurance nei pawl hrang tuamhlawmnak ih liamkuan kha asi.

Neihsiah: Thamtheih le thamtheihlo mi thilri pawl mina lole tuanvo latu in a neih mi le control thei mi mannei mi pawl.

Caakkhai Tuamhlawmnak: Mina harhdamlonak pakhat khat ruangah hmakhatte tuamhlawmnak lole/IU Health siizung ah Emergency Department a neihmi pahtlang in siizung um tuamhlawmnak, siizung umlo in tuamhlawmnak, lole siizung dang in rak thawn ih tuamhlawmnak asi.

Leiba Hlamnak Cuanghmuar Hmalaknak (Extraordinary Collection Actions -ECA): IU Health lole a palai pawl in mina lole tuanvo latu hnen in leiba ngahsal ding ah himi Pawlisi thawn mil in midang hnen ah himi mina lole tuanvo neitu pehpar in phurrit kha an zuar, credit zohhliaktu pawlkom le credit bureau hnen ah thuhla pek, lole dandun lole taza zung lam ah thlen ih thuhla tawlrel hi asi.

Federal Poverty Level (FPL): U.S. Department of Health & Human Services ih lamhmuhsak dandun tuahmi vekin kumkhat sung tuakmi asi. A riruang pawl cu innsang ih minung umzat le an kumkhat sung sumlut dinhmun zoh in tuaktan asi.

Sumsaw Bawmnak: Himi Pawlisi hnuai ih bawmnak ngahtu mina lole tuanvo latu cun Mina Mawhphurh liamkuan ding mi pawl malter ding hrang bawmnak asi.

Sumsaw Bawmnak Dilnak: Dan vekin dilnak cu mina lole tuanvo latu in Sumsaw Bawmnak dil ding ah a thehlut ding asi.

Sumsaw Bawmnak Committee: Revenue Cycle Services team hnatauantu sungtel pawl an si ih Sumsaw Bawmnak Thutluknak tuahmi lungkimlo ruang ih azukhaan mi pawl le Sumsaw Bawmnak dilmi pawl tawlrektu an si.

Sumsaw Bawmnak Thutluknak: Himi pawlisi vekin Sumsaw Bawmnak dilmi pawl kha pe lole pelo kha asi.

Aman Zate: Siizung pawl in siivai tuamhlawmnak ih a cemmi zate kom, pekding ih ruatcia mi, aman tthum hlan, lole zianghman zuhhlan ih mina hnenih aman cemlian zate.

Harsatnak: Nitin nuntukhawsaknak hrang pek ding harsatnak asi.

Innsang: Mina lole tuanvo latu ih federal tax an file tikah an file cihmi bulpak minung hmuahhmuah. Kumkimlo pawl tuanvo latu pawl cun an tuanvo lakmi pawl kha federal tax an file cihlo asilen, tazazung (court) thusuah mi ca cu kumkimlo tuanvo lakmi innsang dinhmun simfiangnak ah thehlut ding asi. Federal tax file nak ca in mina lole tuanvo latu ih sumlut a langfiangterlo asilen, mina lole tuanvo latu in notary tuah mi ca kha thehlut thei asi.

Sumlut: a pung, a hlawk, thla hlawh, hnadang tuannak in sumlut, laksawng, pinsin, hnatuannak ih ngahmi fee, thilri zuar ih ngahmi, innsanter nak in ngahmi sumlut, neihsiah thilri zuar ih hlawk mi, nupi/pasal thennak hnu ih cawmnak ih pek mi, le thilri hmanter ruang ih ngahmi sumlut pawl asi.

Indiana Khuasami: Indiana Administrative code 140IAC 7-1.1-3 dan vekin himi lungkimnak tuah lai ih Indiana ah a umtu kha a sawhduhmi asi.

Insurance Neitu Mina: Pawlkom Company in insurance neitu, cozah hnen in insurance neitu, lole IU Health thawn contract lole lungkimnak rak neitu siin a hlawknak ngahtu ih ruatmi mina kha a kawhhmu asi.

Siivai thawn tuamhlawm tul: Natnak, hliamnak, dinhmun, nathrik, nat langdan pawl khamnak, hmuhsuaknak, le tuamhlawmnak asi ih cumi cu sii lam thawn a mil aw mi tahfung ah a tlingmi asi pei.

Huaplo mi tuamhlawmnak: Mina ih insurance neihmi in a huaplo mi harhdamnak hrang tuamhlawmnak le mina in IU Health in pe ding in contract a tuahlo mi lole lungkimnak a neilo ruang ih a huaplo mi tuamhlawmnak pawl an si.

Mina ih Tuanvo: Zodang hman in a huapsaklo mi tuamhlawmnak cemliam pawl; insurance copay, deductible le a dangdang huaplo mi pawl mina ih liamkuan ding ih ruat mi pawl asi.

Insurance Pekmi Mina: Mina a mahte liamkuan ding ah sumsaw harsatnak a neitu pawl insurance in peksak mi asi.

Insurance neilotu Mina: Pawlkom Company in insurance neilotu, cozah hnen in insurance neilotu, lole IU Health thawn contract lole lungkimnak rak neilotu siin a hlawknak ngahlotu ih ruatmi mina kha a kawhhmu asi.

PAWLISI THUSUAH

2. Sumsaw Bawmnak Thutluknak cu mina ih kum, hrinhnam, biaknak sakhua, taksa rawng, mipa nunau sinak, taksa tlamtlinglo, suahkehnak ram, cithlahtu, le innsang dinhmun parah zoh ih thleidannak umlo in thutluknak tuah asi pei.
3. IU Health cun Sumsaw Bawmnak a um thuhla cu mina hmuahmuah theih ding in nasazet in hmalaknak a nei ding asi.

2. IU Health siibawi pawl himi pawlisi ih a huaplo mi tuamhlawmnak cu insurance neilo mina a pek asilen an liamkuan ding mi ah discount an ngah thei asi.

D. Huaplomi Mina Tuamhlawmnak hrang Discount

1. IU Health cun insurance nei ko nan a insurance in a huaplomi mina tuamhlawmnak ih liamkuān cemmi mina ih tuanvo asi mi ah zatek 75 (75%) cu a Sumsaw Bawmnak vekin a niamsak thei asi.
2. IU Health cun insurance in a huaplo ruangah an rak peksaklo tikah siseh, mina ih dilnak vekin, himi Section D dan vekin Sumsaw Bawmnak a ngahtheitu cu a liamkuān ding niamsak thei asi pei.

2. IU Health cun cohlan mi siikhan siizung emergency department in siseh, siibawi hnen in direct in siizung luttu siseh, siizung dang in rak hluai/kuat mi mina lole tuanvo latu pawl cu a tanglam ih tarlang mi program pakhat khat ngahthei ding an sile, Sumsaw Bawmnak ngahthei ding in ruatcia an si:

- a. Medicaid (state hmuahhmuah)
 - b. Indiana Children's Special Health Care Services
 - c. Healthy Indiana Plan
 - d. Hospital Presumptive Eligibility (HPE) timi a ngahtu mina

- f. Mina lole innsang sungtel ah hnatuan mi umlo asilen, WorkOne zung in statement lak ih thehlut ding.
 - g. Nu le pa thenawknak le nauhak kilkhawinak ca, a um asilen, thehlut ding.
